**Description:** Authorization of Illinois Tollway's Business Diversity Program of 2023,

effective July 1, 2023.

**Background:** As part of an ongoing effort to reduce barriers to minority and female

participation in Tollway contracts and ensure the Tollway is not a passive participant in ongoing discrimination, this Resolution terminates the

Disadvantaged Business Enterprise program passed by the Board in 2005 and

authorizes the Business Diversity Program of 2023.

The Business Diversity Program of 2023 is based on the findings of Colette Holt & Associates, which firm the Tollway engaged to conduct a disparity study, and new evidence demonstrating the continuing need for such a program as well as the compelling interest in continuing to support aspirational national goals. By utilizing appropriate contract provisions and other means, including race and gender-neutral and race and gender-conscious remedies, the Business Diversity Program of 2023 will help ensure that the Tollway continues to remedy the effects of discrimination in its contracting.

By this Resolution, the Tollway reaffirms its commitment to non-discrimination in its procurement process. To ensure the Tollway's program remains consistent with best practices and legal precedent requiring narrowly tailored programs, the Business Diversity Program of 2023 will terminate on July 1, 2030. Thereafter,

the program will be reauthorized as necessary.
