By the referenced Resolutions, the Board of Directors approved expenditures of up to \$442,000,000 for this purpose as set forth below:

- Jane Addams Memorial Tollway (I-90) - \$107,600,000
- Veteran's Memorial Tollway (I-355) - \$2,000,000
- Reagan Memorial Tollway (I-88) - \$2,500,000
- Tri-State Tollway (I-94/I-294) - \$115,000,000
- Elgin O'Hare Western Access - \$184,900,000
- I-294/I-57 Interchange - \$30,000,000

Based on developments encountered during the continued advancement and progression of work, and in view of savings realized in certain corridors, the Tollway's Engineering Department determined that the amounts authorized to cover the above-described utility costs should be revised as set forth below and that total authorized expenditures should be increased by \$76,000,000.
