Illinois Tollway Disparity Study Background

- Released in October 2015
- Examined the Tollway's contracting practices and its Disadvantaged Business Enterprise (DBE) Program
- The Disparity Study provides a strong basis for continuing the Tollway's DBE Program



Diversity Advisory Council (DAC) Background

- Members represent more than 20 advocacy agencies
- Three subcommittees created to study Tollway policies, existing programs and workforce development
- Developed recommendations for Tollway Board consideration



Illinois Tollway Disparity Study Recommendations

14 total recommendations

- Ensure bidder non-discrimination and fairly priced subcontractor quotations
- Increase training opportunities for prime contractors
- Continue to review contract sizes and scopes
- Review experience requirements



Illinois Tollway Disparity Study Recommendations

- Revise contract retainage procedures
- Expand the Small Business Initiative
- Continue to apply race- and gender-conscious measures to appropriate contracts
- Use the Disparity Study to set DBE contract goals
- Expand the Mentor/Protégé Program to construction contractors



Illinois Tollway Disparity Study Recommendations

- Review DBE contract compliance policies and processes
- Consider measures to encourage prime contractors to utilize new DBEs
- Implement an electronic contract data collection and monitoring system
- Develop performance measures for DBE Program success
- Conduct regular DBE Program reviews



Diversity Advisory Council Recommendations

13 total recommendations

- Continue the missions of the Board Diversity and Inclusion
 Committee and Diversity Advisory Council indefinitely
- Evaluate all proposed Tollway goods and services contracts to determine shortest possible contract term
- Evaluate all proposed Tollway Job Order Contract (JOC) Facilities
 Program advertisements to determine shortest possible
 contract term



Diversity Advisory Council Recommendations

- Continue unbundling construction contracts and review the process to identify any additional opportunities
- Include marketing component in current and new technical assistance programs
- Create a Mentor/Protégé Program for Construction
- Issue an RFP for goods and services technical assistance
- Create a Construction Contract Bidding Guide



Diversity Advisory Council Recommendations

- Establish a workforce development technical assistance program
- Create committee to work with top five trade unions to increase member diversity
- Require Tollway contractors to submit Equal Employment Opportunity (EEO) workforce projections prior to start of projects
- Post contractor EEO compliance data online
- Commission a workforce disparity study



Tollway Staff Recommendations Overview

Tollway staff recommendations must consider:

- Overall agency mission
- Responsibility to bondholders
- Limitations on how agency funds can be spent
- Available Tollway resources



Completed and Ongoing Recommendations

- Revise contract retainage procedures
- Continue the Diversity and Inclusion Committee and Diversity Advisory Council
- Continue unbundling construction contracts
- Increase training opportunities for prime contractors
- Continue reviewing contract sizes and scopes
- Include marketing in technical assistance programs
- Develop DBE performance measures



- Create Construction Mentor/Protégé Program
- Establish workforce technical assistance program
 - Research training and placement programs as well as physical training locations
- Complete Construction Bidding Guide
- Issue goods and services technical assistance RFP
- Continue applying race- and gender-conscious measures




- Use Disparity Study data to set DBE contract goals
