# **Background**

The Illinois State Toll Highway Authority ("Tollway"), pursuant to Resolution No. 19435 adopted on July 28, 2011, has conducted 15 public hearings in its 12-county service area and solicited written and online public comments on a proposed capital plan known as "Move Illinois: The Illinois Tollway Driving the Future" ("Plan") (Exhibit A) and a proposed toll increase on passenger vehicles (Exhibit B). The Plan provides for a wide variety of capital improvements necessary to keep the existing Tollway system in a state of good repair, including the reconstruction and widening of the Jane Addams Expressway (I-90) from Rockford to the Kennedy Expressway, the reconstruction of the central Tri-State (I-294), and preserving a large section of the Reagan Memorial (I-88) west of the Fox River. The Plan also provides for several major capital improvements, including the construction of the O'Hare West By-Pass and Western Extension, reconstruction, widening and extension of the Elgin-O'Hare Expressway, and construction of the I-57/I-294 interchange, as well as planning for one or more additional toll highways, including the North Extension of Route 53, with east and west branches on Route 120, and the Illiana Expressway. Such projects are contemplated by the Go-To 2040 Plan of the Chicago Metropolitan Agency for Planning, the federally recognized metropolitan planning agency for the Chicago area. The proposed toll increase is the first toll increase on passenger vehicles covered by I-PASS accounts since 1983. Although the proposed toll increase set forth in Exhibit B does not contain a category for congestion pricing, the potential value of such a mechanism is recognized and will continue to be considered as future circumstances warrant and as authorized by Resolution No. 18516 adopted on November 20, 2008.

The Tollway gave notice of the public hearings pursuant to sections 11(c) and 14.2 of the Tollway Highway Act concerning the proposed Plan and the toll increase. At least one Director attended 13 of the 15 public hearings. Five Directors attended the public hearings in Du Page County on

August 18, 2011 and in Cook County on August 23, 2011. Each director has been supplied with a compilation of testimony and written comments submitted in connection with each public hearing. For months prior to the hearings the Tollway Board heard and discussed detailed presentations on the Tollway's financial condition, the capital

investments necessary to keep the existing Tollway system in a state of good repair, and possible new transportation projects that might serve residents and businesses in the region served by the Illinois Tollway. In addition, the Tollway participated in the Elgin-O'Hare West Bypass Advisory Council, hosted Earth Day Transportation Summits, received recommendations from its Strategic Advisory Team, participated in a listening tour where members of the public and elected officials had an opportunity to share their vision for the Tollway's future, and engaged in productive discussions with the Illinois Department of Transportation, the Regional Transportation Authority, and a variety of transportation, business, labor and planning organizations.

#### Resolution

The Plan attached as Exhibit A is approved and the Executive Director is authorized to seek the Governor's approval of the Plan pursuant to section 14.1 of the Toll Highway Act; and

Beginning at 12:01 a.m. on January 1, 2012 the toll rates for passenger vehicles shown on Exhibit B shall go into effect. The Executive Director shall post notice of the new toll rates as required by section 11(c) of the Toll Highway Act at least 30 days before the new rates go into effect; and

The toll rates approved via Resolution No. 18516 adopted on November 20, 2008 shall remain in effect; and

The Executive Director is authorized to include planning for possible accommodation of public transit service such as bus rapid transit or commuter rail in Tollway corridors that are part of the Plan; and

The Executive Director is authorized to file with the Trustee appointed pursuant to the Amended and Restated Trust Indenture (1999) any necessary Traffic Engineer certificate filed pursuant to section 713.5 of that

Indenture recommending that the toll rate schedule (Exhibit B) be adopted; and

The Chief of Finance is authorized to declare the Official Intent of the Tollway to issue obligations to reimburse the Tollway for expenditures made for capital projects of the Tollway, within the meaning of Treasury Regulation 1.150-2, as amended; and

The Tollway shall employ its best, reasonable and lawful efforts to employ Illinois residents and use companies located in Illinois in the execution of the Plan.
