Background

The Tollway and the Kane County Forest Preserve District (sometimes referred to as the "District") wish to enter into an Intergovernmental Agreement. The Tollway, as part of the widening and reconstruction of the Jane Addams Memorial Tollway (I-90) from the John F. Kennedy Expressway to Illinois Route 39, is replacing the I-90 bridge over the Fox River as one of its multiple contracts. There are three (3) pedestrian bridges which are the property of the District, and the Tollway, as part of the Project, is removing the pedestrian bridge that is supported by the underside of the Toll Highway bridge, removing the pedestrian bridge in the southwest quadrant, and removing the pedestrian bridge in the northwest quadrant. The District requests that the Tollway include in its Project the replacement in kind of the pedestrian bridge supported by the underside of the I-90 bridge, replacement of the pedestrian bridge in the southwest quadrant and extension of the culvert in the northwest quadrant eliminating the need for the existing pedestrian bridge, restoring the pedestrian paths to their existing conditions. It is in the Tollway's best interest to agree to these requests and enter into an agreement governing the same.

Resolution

The General Counsel and the Chief of Engineering are hereby authorized to enter into an Intergovernmental Agreement with the District for pedestrian bridge work in substantially the form of the Intergovernmental Agreement attached to this Resolution, the Chairman or the Executive Director is hereby authorized and directed to execute the Agreement, and the Chief of Finance is authorized to issue payments as required by the Intergovernmental Agreement.

Background

The Tollway and the Village of New Lenox (hereinafter referred to as the "Village") entered into an IGA dated April 9, 1996 (hereinafter referred to as the "Original Agreement") where the Tollway agreed to construct interchange improvements at and near I-80 and U.S. Route 6 including what is referred to as the Summerfield Road Access. Pursuant to the terms of the agreement, the Tollway committed to pay the costs of the improvements at the time estimated to be \$604,000.

A Supplemental Intergovernmental Agreement dated August 29, 2002 (hereinafter referred to as the "Supplemental Agreement") was entered into by the parties shifting the construction responsibilities away from the Tollway and to the Village. As a result, the Village is currently the lead agency responsible for the construction of the Summerfield Road Access subject to reimbursement consistent with the financial commitments outlined in the Original Agreement.

Additionally, the Tollway and the Village executed an Intergovernmental Agreement dated June 13, 2006 which provides for the sharing of costs associated with the South Extension of I-355. More specifically, the Village agreed to provide a local financial contribution in the amount of \$1,500,000 to be paid to the Tollway over a period of seven (7) years (hereinafter referred to as the "Local Contribution Agreement").

To date, the Village has made contributions toward its Local Contribution Agreement commitment totaling \$350,000. The Village has offered to release the Tollway from its Summerfield Road Access financial obligation if it applies the \$604,000 Summerfield Road Access commitment as a credit toward the Village's \$1,500,000 local contribution commitment. The \$350,000 paid to date by the Village; combined with the \$604,000 Summerfield Access credit totals \$954,000. If the Village's Offer is approved, the Village will satisfy the remaining \$546,000 balance of its local contribution commitment in full.

Background

The Illinois Tollway applied for and the Federal Highway Administration (FHWA) awarded the Tollway a \$150,000 grant which may be used by the Tollway to reimburse it for services necessary to implement the FHWA's Infrastructure Voluntary Evaluation Sustainability Tool (INVEST). The terms and conditions of the grant have been memorialized in an Intergovernmental Agreement between the parties.

INVEST is the FHWA's Web-based self-evaluation tool of sustainability best practices that enables transportation practitioners to ensure the sustainability of their projects, as well as their planning, operations and maintenance processes. INVEST is intended to identify and recognize above-and-beyond efforts towards sustainability and encourage sustainability progress within the field of highway transportation.

It is anticipated that the Illinois Tollway will use INVEST to evaluate several completed projects to create a historic baseline of sustainable practices, as well as evaluate current Move Illinois projects to help integrate sustainability best practices. When the evaluation is complete, Move Illinois projects will be used as INVEST case studies to aid other transportation agencies in their sustainability efforts.
