Background

This will result in significant cost savings to the Tollway in an amount equal to the interest that would otherwise be due on unpaid balances. The payment required to satisfy this obligation in full on September 1, 2013, is \$8,226,538.09, including interest through that date.

The Executive Director, or the Chief of Staff and/or the Land Acquisition Manager, subject to form and constitutionality approval of the General Counsel, state and federal law and then existing Land Acquisition policies and procedures are authorized to enter into and execute any real estate contract for the acquisition or conveyance of all needed real estate for the Project; the Land Acquisition unit is authorized to acquire and purchase property by and through escrow closings with its approved title insurance vendors; the Chief of Finance is authorized to issue warrants from time to time to pay for any and all land acquisition fees and costs including but not limited to purchase price, acquisition fees, costs, closing costs, appraisers, negotiators, surveyors, title insurers, deposit preliminary just compensation amounts, deposit sums to close in escrow, agents, relocation costs, Special Assistant Attorneys General and all such other experts retained for the purpose of acquiring all real estate needed for the project as well as the Identified Parcels and for the payment of preliminary just compensation as well as final just compensation to the owners of said Identified Parcels and to pay any and all such other acquisition costs and expenses, not to exceed the sum of \$30,000,000.00.

Background

It is in the best interest of The Illinois State Toll Highway Authority ("Tollway") to enter into an Intergovernmental Agreement with the County of Cook ("County") allowing the Tollway to earn environmental mitigation credits. As part of the Tollway's 15 year Capital Program, it is is disturbing wetlands and waters and must mitigate these impacts. As a condition of certain federal and state construction permits, the Tollway is required to create enhanced or new wetlands or to purchase wetland mitigation credits created by another entity.

The County has acquired the Orland Grassland South Addition, which consists of approximately 160 acres, located at 108th Avenue and 179th Street in or near Orland Park, Illinois. This property is well suited for environmental improvements which will generate mitigation credits for the Tollway. The County has agreed to allow the Tollway to improve its property by constructing an entrance road, parking lot, restroom/well, boardwalks and a path system within the currently undeveloped property. Beyond the construction costs which have been or will be included in Tollway construction contracts, this Intergovernmental Agreement will not result in any cost to the Tollway.

Resolution

The Chief Engineer and the General Counsel are authorized to negotiate and prepare an Intergovernmental Agreement between The Illinois State Toll Highway Authority and Cook County in substantially the form of the Intergovernmental Agreement attached to this Resolution, the Chair or the Executive Director is authorized to execute said agreement.

Background

The Tollway intends to improve the Elgin O'Hare Expressway by extending the expressway from its eastern terminus at Rohlwing Road (Illinois Route 53) to O'Hare International Airport and by connecting the Jane Addams Memorial Tollway (I-90) with the Tri-State Tollway (I-294). The proposed improvements include construction of an integrated system of electronic tolling infrastructure and ITS supported by a fiber optic communication network along the Elgin O'Hare Western Access corridor. In order to allow for opening the initial segment between U.S. Route 20 and I-290 as a toll facility, and in order to connect to its fiber optic system and to its Central Administration building in Downers Grove upon initial segment construction, the Tollway is desirous of installing fiber optic communications along I-290 between I-355 and I-90 within a duct package owned and under the jurisdiction of the Illinois Department of Transportation (IDOT). In return for allowing the Tollway to install the fiber optic communications as set forth above, IDOT has requested the installation of fiber optic communications along the Elgin O'Hare Western Access corridor in order to provide for communications to IDOT's Maintenance Facility located on Rodenburg Road in the Village of Schaumburg and to allow IDOT to connect to its fiber optic systems located within the project area on U.S.20 (Lake Street), Illinois Route 19 (Irving Park Road), Illinois Route 53 (Rohlwing Road), I-290, Illinois Route 83 (Busse Road), Illinois Route 72 (Touhy Avenue), Elmhurst Road, Oakton Street, and Illinois Route 64 (North Avenue). The provision of services between the Tollway and IDOT at no cost is consistent with longstanding practice between the agencies.

Resolution

The General Counsel and the Chief of Engineering are hereby authorized to negotiate an Intergovernmental Agreement with the Illinois Department of Transportation in substantially the form of the Intergovernmental Agreement attached to this Resolution, the Chair or the Executive Director is hereby authorized and directed to execute the Intergovernmental Agreement, and the Chief of Finance is authorized to issue payments that may be required by the Intergovernmental Agreement.

Background

It is in the best interest of the Illinois State Toll Highway Authority to settle a personal injury lawsuit titled <u>Patricia A. Shutts v. ISTHA</u>, No. 2009 L. 001866, filed in the Circuit Court of Cook County.

On Dec. 29, 2008, Plaintiff, a 52 yr. old female, was driving north on I-294 at Mile Post 52.5, which was undergoing re-construction under the "Congestion Relief" program. A cast iron plowable raised pavement marker (RPM) was propelled through the windshield of plaintiff's automobile striking her in the face. She thereafter lost control and struck 2 other cars before coming to rest. Plaintiff suffered a large laceration from her mouth through her left mandible area, along with some broken teeth. Plaintiff had several reconstructive facial surgeries and per the doctor could have further scar revision. She also required dental surgery. She incurred medical expenses of about \$42,000. She missed about one month from her work as a spiritual counselor at a Catholic retreat for nuns where she earned about \$2,500 per month.

The Tollway filed a motion for summary judgment that asserted plaintiff had no evidence that the RPM came from the Tollway's pavement and that the Tollway had no notice that the RPM was loose or might become loose. Plaintiff has retained an engineering expert to testify the Tollway should have known of the danger posed by RPMs. Accordingly, obtaining summary judgment is very much in doubt.

Plaintiff re-initiated settlement discussions by dropping her prior demand for \$750,000, down to \$350,000. Because a denial of the summary judgment motion would lead to an increased settlement demand and a jury trial if no resolution is obtained, it was prudent to attempt to settle the matter before that could occur. After further negotiations staff counsel has arrived at a tentative (subject to Board approval) agreed settlement in the amount of \$225,000 in exchange for the entry of an agreed order of dismissal.

Resolution

The proposed litigation settlement in the amount of \$225,000.00 is approved. The General Counsel is authorized to finalize the settlement agreement consistent with the terms presented to the Board, the Chair or the Executive Director is authorized to execute the final settlement agreement, and the Chief of Finance is authorized to issue a warrant in the amount of \$225,000.00 in payment thereof.
