The Tollway's Engineering Department by and through its Land Acquisition Manager, together with employees, vendors and agents are authorized to acquire real estate interests and to spend sums up to an amount not to exceed \$14,300,000.00 and pay for any and all land acquisition fees and costs including but not limited to consideration, purchase price, fees, costs, closing costs, appraisers, negotiators, surveyors, title work, title insurers, agents, owners, relocation costs, Special Assistant Attorneys General and all such other experts retained for the purpose of acquiring the Identified Parcels and for the payment of preliminary just compensation as well as final just compensation and to pay any and all such other acquisition costs, fees and expenses.
